- El Funding and Tenders opportunities es el Portal que tiene la Comisión Europea en Internet para los Programas Europeos de Gestión Directa (PEGD). En él podremos buscar convocatorias de programas que estén abiertas, enviar nuestras propuestas a una convocatoria determinada, darnos de alta como potenciales evaluadores, buscar los proyectos que se han financiado en anteriores convocatorias y, en definitiva, encontrar toda la información sobre cada uno de estos programas.
- Es el punto de entrada para participantes y expertos en PEGD gestionados por la Comisión Europea y otros organismos de la UE.
